A motion was made by Trustee Peronto, seconded by Trustee Miller, that the committee recommend to the Board to approve a temporary exemption to rebalance ranges pending implementation of the revised diversifying strategies portfolio. Motion passed by unanimous voice vote.

MWBE Utilization Report

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided preliminary data as of June 30, 2024, on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. TRS exceeded its brokerage goals by 28.8% for US equity

and 14.1% for global fixed income. TRS missed its brokerage goal by 2.2% for international equity. As of June 30, 2024, MWBE assets as a percent of total plan were 29.78%, which is 7.78% over the TRS fiscal year 2024 utilization goal of 22%. Documentation is on file.
