Diversity Report

<u>Diverse and Emerging Managers Program: Commitments and Gra</u>duations

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided an overview of the MWBE Portfolio and highlighted companies that have graduated from the Emerging Managers program into the main TRS Portfolio. Documentation is on file.

<u>MWBE Utilization Report</u>

Jose Gonzalez, Senior Investment Officer – Diverse & Emerging Managers, provided final data as of June 30, 2024, on the utilization of minority-owned brokers and minority-owned investment managers within the TRS investment portfolio. TRS exceeded its brokerage goals by 28.9% for US equity, 2.1% for international equity, and 14.1% for global fixed income. As of June 30, 2024, MWBE assets as a percent of total plan were 29.8%, which is 7.8% over the TRS fiscal year 2024 utilization goal of 22%. Documentation is on file.

TRS staff conducted the annual review of the System's MWBE utilization goals for minority brokerage and investment management and proposed the following FY2025 minority utilization goals.

- Increasing the goal for utilization of MWBE asset managers from 22% to 23%. This internal goal exceeds the Illinois General Assembly's legislated aspirational goal.
- Increasing the Domestic Equity MWBE brokerage utilization goal from 35% to 40%.
- Maintaining the International Equity MWBE brokerage utilization goal of 17%
- Maintaining the Global Income MWBE trading utilization goal of 17%.
- Maintaining the existing investment management fee goal range of 8.0 11.5% of total fees paid.

The above goals will be included in the TRS Investment Policy, Section 20: Improving Access to the TRS Investment Process. Documentation is on file. A motion was made by Trustee Hirshman, seconded by Trustee Pfeiffer, that the Committee recommend to the Board to approve the recommended FY2025 MWBE utilization goals as presented. The motion passed by unanimous voice vote. Motion carried.

Global Income Strategies Annual Review

Chloe Ariss, Investment Analyst – Global Income Strategies; Katie DellaMaria, Senior Investment Officer – Global Income Strategies; and Corbin Freres, Senior Investment Officer – Global Income Strategies provided an overview of the global income portfolio and proposed recommendations based on this

Long Term Treasury Search Index

One of the firms declined the invitation. Raymond de Castro, Laura May, Marcus Tom, and Greg Ormand of BlackRock provided a presentation to the committee. Documentation is on file. A motion was made by Trustee Hunt, seconded by Trustee Peronto, that the Committee recommend to the Board to approve the selection of BlackRock for the management of the Long Term Government Bond Index Fund within the Diversifying Strategies Composite. The motion passed by unanimous voice vote.
