May 1, 2020 Board of Trustees Special Election **Petition Instructions**

The enclosed petition must be used to nominate an active teacher to serve on the Board of the Teachers' Retirement System of the State of Illinois (TRS) for a 3-year term to commence July 15, 2020. A special election will be held May 1, 2020 to fill an additional active teacher trustee position created by Public Act 101-0610. TRS board elections are governed by the Illinois Pension Code, 40 ILCS 5/16-165. Board election procedures are explained in 80 Ill. Admin Code 1650, Subpart L (1650.1000 - 1090).

Please review the following instructions carefully. Petitions are explained in TRS Administrative Rule 1650.1010. Questions should be emailed to Communications Managing Editor Kathy Boehme at kboehme@trsil.org for response.

Trustee Candidates

- A candidate for a TRS Teacher Trustee board position must be a member of TRS who meets the definition of "teacher" as defined in the Pension Code, 40 ILCS 5/16-106.
- Beginning July 15, 2020, not more than four of the five teachers elected to the Board may be active members • of the same statewide teacher organization as defined in 40 ILCS 5/16-165 (d-5).
- Each candidate must complete a **Candidate's Nominating Petition** (use form available on the TRS website) ٠ indicating the statewide teacher organization(s) to which they have belonged during the five years preceding the election as required by 40 ILCS 5/16-165(d-5), and file the original completed petition bearing the candidate's notarized signature with the System no later than 4:30 p.m. on January 31, 2020.

Petition Signers

- To be eligible to nominate a Teacher Trustee candidate, the petition signer must be a member of TRS who is a "teacher" as defined in 40 ILCS 5/16-106.
- Petition signers must furnish an original signature and complete address (street address, city, state, zip). For verification purposes, a telephone number is also requested.

Petition Circulators

- Before obtaining signatures, complete the top portion of the petition. Blank petitions may be duplicated in any quantity.
- After obtaining at least 500 eligible signatures, complete and sign the certification portion at the bottom of the petition. Your signature must be notarized.
- To be valid, a petition must bear original signatures of eligible petition signers. Submit completed petitions to TRS between January 17 and no later than 4:30 p.m. on January 31, 2020 to:
